2.042 total combined acres Right of Way (R/W) Deed of Record: Permanent Parcel Number (PPN) 33-017-00-020-00 and PPN 33-017-00-021-00, Scott Rice, Document Number (DN) 2020-00002335, Volume 704, Page 518, Tracts 1 and 2 of Ashtabula County Records and Deeds (ACRD). 3456 Footville - Richmond Road.

Situated in the Township of Morgan, County of Ashtabula and State of Ohio and known as being part of Original Lots 113, 123, 124, 133 and 134 within said Township and Township 10N, Range 4W in the Connecticut Western Reserve and bounded and described as follows:

Beginning at a 1" iron pin in monument box found at the centerline intersection of Brook Road (aka Brooks Road, TR 110, 60 feet wide) and Footville – Richmond Road (CR 12, Field Book 449-A, Section H, 60 feet wide), being a northeasterly corner of PPN 33-017-00-022-02 as conveyed to The Nature Conservancy (NC), recorded in DN 2014-00009505, Volume 574, Page 309 of ACRD, a northwesterly corner of the parcel herein described and <u>The Principal Place of Beginning of this</u> <u>Survey</u>.

Thence North 89°24'08" East, along the centerline of said Footville – Richmond Road, a frontage distance of 865.94 feet to the northwesterly corner of PPN 33-017-00-019-01 as conveyed to William Zigmont, recorded in DN 2010-00003713, Volume 473, Page 1616 of ACRD, being a northeasterly corner of the parcel herein described.

Thence South 00°21'12" East, along the westerly line of said Zigmont's land, along a westerly line of PPN 33-017-00-019-00 as conveyed to The Nature Conservancy (NC1), recorded in DN 2000-00021664, Volume 146, Page 225 of ACRD, passing through a 5/8" iron pin set at 30.00 feet, a 5/8" iron pin with cap bearing "A TERRA

6634" found at 30.35 feet, a total distance of 1772.25 feet to a 5/8" iron pin set at a southwesterly corner thereof.

Thence North 89°19'13" East, along a southerly line of the said NC1 parcel 362.19 feet to a 5/8" iron pin set at a northeasterly corner of the parcel herein described.

Thence South 01°00'13" East, along a westerly line of the said NC1 parcel, 798.52 feet to a 5/8" iron pin with cap bearing "A TERRA 6634" found at a southwesterly corner thereof.

Thence North 88°18'59" East, along a southerly line of the said NC1 parcel, passing through a 5/8" iron pin corner reference set at 414.77 feet, a total distance of 489.77 feet to a point in the center of Rock Creek at a northwesterly corner of PPN 33-022-00-019-00 as conveyed to The Nature Conservancy (NC2), recorded in DN 1998-00023859, Volume 108, Page 6915 of ACRD, being a northeasterly corner of the parcel herein described.

Thence along the westerly side of the said NC2 parcel, along the center of said Rock Creek, the following four (4) courses:

- 1.) South 27°31'01" East, 83.41 feet to an angle point therein.
- 2.) South 18°01'58" West, 72.11 feet to an angle point therein.
- 3.) South 36°16'17" West, 61.75 feet to an angle point therein.
- 4.) South 68°23'17" West, 117.79 feet to a bifurcation (fork) in said Rock Creek.

Thence continuing along the westerly side of the said NC2 parcel, along the easterly distributary of said Rock Creek, the following seven (7) courses:

- 2.) South 78°15'49" East, 100.16 feet to an angle point therein.

South 74°45'10" West, 118.32 feet to its intersection with the center of the Grand River at an angle point therein, known as the "upper mouth" of Rock Creek, being a southwesterly corner of the said NC2 parcel and a northeasterly corner of PPN 33-023-00-002-00 as conveyed to The Nature Conservancy (NC3), recorded in DN 1991-00008707, Volume 56, Page 6287 of ACRD.

Thence along the northerly and westerly sides of the said NC3 parcel, along the center of the Grand River, the following twelve (12) courses:

- 12.) South 52°01'13" West, 143.83 feet to a northwesterly corner of the said NC3 parcel.

Thence South 01°57'30" West, along a westerly line of the said NC3 parcel, passing through a 5/8" iron pin corner reference at 75.00 feet, a total distance of 128.59 feet to a 3/4" iron pin in concrete found at the northeasterly corner of PPN 33-022-00-015-00 as conveyed to Rock Creek Conservation Club (RCCC), recorded in INST 2019-00001350, Volume 677, Page 412 of ACRD, being a southeasterly corner of the parcel herein described.

Thence South 89°15'41" West, along the northerly line of the said RCCC parcel, 824.05 feet to a 1" iron pipe found on an easterly line of PPN 33-022-00-014-01 as conveyed to The Nature Conservancy (NC4), recorded in DN 1986-00016966, Volume 35, Page 8836 of ACRD at the northwesterly corner of the said RCCC parcel, being a southwesterly corner of the parcel herein described.

Thence North 12°56'59" West, along said easterly line of the said NC4 parcel, passing through a 5/8" iron pin corner reference set at 113.78 feet, a total distance of 188.78 feet to a point in the center of the Grand River.

Thence continuing along the easterly and northerly side of the said NC4 parcel, along the center of the Grand River, the following seventeen (17) courses:

- 1.) North 40°13'22" West, 91.30 feet to an angle point therein.
- 2.) North 06°45'13" East, 119.73 feet to an angle point therein.
- 3.) North 27°33'10" East, 202.93 feet to an angle point therein.

5.) North 40°57'20" East, 219.58 feet to an angle point therein.

- 10.)North 33°36'05" West, 179.36 feet to an angle point therein.
- 11.) South 85°32'42" West, 296.58 feet to an angle point therein.
- 12.) South 58°27'53" West, 136.14 feet to an angle point therein.
- 13.) South 34°03'42" West, 239.77 feet to an angle point therein.
- 14.) South 79°43'40" West, 118.14 feet to an angle point therein.
- 15.) North 80°19'10" West, 125.28 feet to an angle point therein.
- 16.)North 63°48'01" West, 408.86 feet to an angle point therein.
- 17.) North 76°28'14" West, 344.97 feet to a point on an easterly line of PPN 33-017-00-022-00 as conveyed to Nancy E. Cornell, recorded in DN 2015-00002084, Volume 583, Page 481 of ACRD at a northwesterly corner of the said NC4 parcel, being a southwesterly corner of the parcel herein described.

Thence North 01°03'40" East, along said easterly line of Cornell's land, passing through a 5/8" iron pin corner reference set at 200.00 feet, a total distance of 567.82 feet to a 5/8" iron pin with cap bearing "PETER 6420" found, being a northwesterly corner of the parcel herein described.

Thence North 88°08'45" East, along a southerly line of said Cornell's land, 188.71 feet to a 5/8" iron pin set in the old riverbed of the Grand River known as "Oxbow Lake", at a southeasterly corner thereof.

Thence North 17°06'25" East, along an easterly line of said Cornell's land, along an easterly line of the aforesaid NC parcel (PPN 33-017-00-022-02), passing through a 5/8" iron pin set at 86.20 feet at the top of bank of said old riverbed on the centerline and at the southerly end of the aforesaid Brook Road, passing through a 5/8" iron pin with cap bearing "PETER 6420" found at 97.93 feet, and continuing along said centerline, a total distance of 2207.42 feet to **The Principal Place of Beginning of this Survey** and containing 126.457 acres of land, of which, 2.042 acres are within the R/W of said Footville – Richmond Road and Brook Road, surveyed in February, 2022 by D.B. Kosie and Associates (Robert L. Kosie, Registered Professional Land Surveyor No. 8167). Bearings are to True North using The ODOT VRS and CORS GNSS network (NAD83 - 2011, NAVD88, GRS80, and Geoid2012B). Be the

The intent of this survey is to combine PPN 33-017-00-021-00 together with PPN 33-017-00-020-00 as conveyed to Scott Rice, recorded in DN 2020-00002335, Volume 704, Page 518, Tracts 1 and 2 of ACRD. Known as being 3456 Footville Richmond Road.

All 5/8" iron pins set shown herein noted as being 5/8" x 30" iron (steel) rebar pins (#5 rebar) with yellow plastic cap bearing "KOSIE P.S. 8167".
